Additional – COVID19 Measures for Trinity College London Practical Examination

- All candidates must complete their safe-entry before they enter the Exam Venue.
- All candidates must have their **temperature taken by the examination officer** and if the candidates' temperature is above 37.5, they will not be allowed to take the examination.
- If any candidate is found not feeling well, the examination officer has the right to disallow her/him to take the examination.
- All candidates must wear their face masks and/or face shields at all times inside and outside the examination room.
- All candidates need to sanitize their hands by the examination officer before they enter the exam room. However if they are allergic to the hand sanitizers, please kindly inform the examination officer in advance.
- If the candidates have to remove their masks for any medical/breathing reasons during their examination time, they **MUST** wear their **face shields and stand at least 2.5 metre away from the examiner**. (If candidates remove their mask, Face shields **cannot be** removed at all times.)
- **It is the candidates' responsibility to bring his/her own face shield (if required.) The examination venue will NOT provide any face shield and extra mask.**
- If candidates have removed their masks for any medical/breathing reasons during their exam time, they **must wear back their masks immediately after their exam before they exit the exam room.**
- There will be breaks in between after each candidate for sanitization of the exam room.
- Candidates next in line for exam must not be waiting outside the door to avoid intermingling.
- Candidates must stand on the appropriate floor demarcations outside and inside the exam room to ensure safe distancing.
- Candidates must avoid speaking too loud outside the exam room.
- All candidates are NOT allowed to bring in their mobile phones or other electronic devices.
